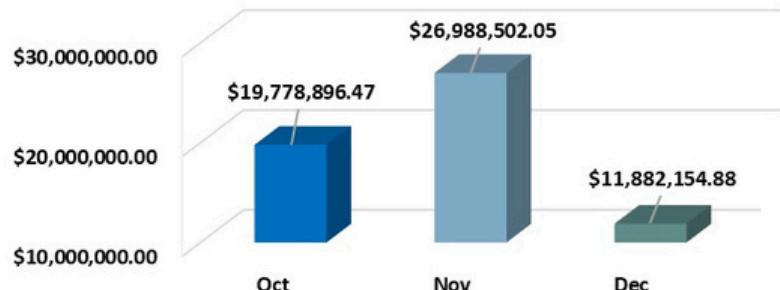

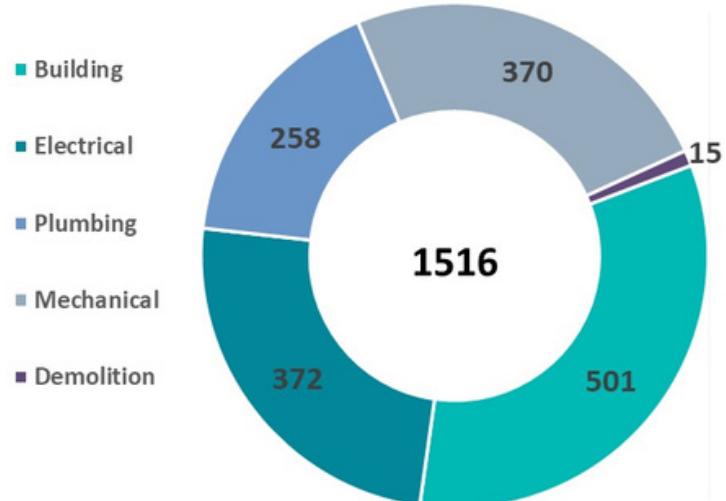
MARKET VALUE OF ALL CONSTRUCTION*

- The number of permitted dwelling units 2nd quarter year-to-date increased by 200% from FY24 to FY25. This was due to the permitting of significantly more apartment units through the 2nd quarter of FY2025.
- During this same time period, the market value of all construction increased by 123% as a result of the increase in permitted dwelling units.
