4. Update on Bancroft Ponds Projects
 - Outdoor Classroom Grant Proposal, Current Plan and Review of Presentation to the Parks Board – John Conner reported that the outdoor classroom project will be presented at the Parks Board Meeting on September 8. John is waiting for Nathan McLeod to finish the ADA part of the design. John will check on any ordering of trees and supplies that could be placed in a large city order.
 - Dogs Off Leash –Dave Westfall reported that he was advised by Morgan Valliant that people may use 911 to report unruly dogs and they will route the call to the animal control. Fish Wildlife and Parks take care of the wildlife in the park and city.
 - Cleaning Day at Bancroft – Dave Westfall reported that the Missoula Co. Health Dept. will not allow the large-scale clean-up day this Friday, September 4, due to COVID 19 restrictions.
 - Birding Area – Colleen Biehl reported that the weekly watering will go until the end of the month. Molly Dillingham will be contacted for the Fall plan in that area.
