Summary Description and rationale of project and funding sources:

Reconstruction to include curb/gutter/sidewalks, bike facilities, street lighting, and traffic calming. The project creates a City-owned developable parcel for housing and supports other infill development along the corridor. BaRSAA and LOFT gas tax funding would be used to leverage MRA funds.

History & Current Status: Impact if Cancelled or Delayed

This project addresses safety and connectivity issues, implements a portion of the neighborhood greenway network, and supports affordable housing goals. Preliminary engineering design is complete and included substantial public/neighborhood outreach.
