The Missoula Fire Department Maintenance Division is a critical cog in the operations of the Missoula Fire Department. The Maintenance Division consists of 3 full time employees that are responsible for the maintenance and repair fo 32 emergency vehicles, 14 department vehicles, 5 stations , training burn tower, and the boat house. The training needs of the Maintenece Division are unique based on the critical nature of the vehicles they are repairing and maintaining. The staff of the Maintenance Division is responsible to maintain their certification of Emergency Vehicle Technician (EVT). This certification provides the necessary education and skills to repair, diagnose, and maintain emergency response vehicles to NFPA 1911,1915,1071, and 1451. As the Missoula Fire Department continues to grow so do the training and skill demands of the Maintenance Division.

As identified in the 2020-2023 City of Missoula Strategic plan, Organizational excellence strategic goals 2. Line 6 “encourage employee growth and improvement by providing regular training opportunities suited to the departments and the employee’s goals.
