**Summary Description and rationale of project and funding sources:**

Restore East Caras and Evelyn Borg Johnson Parks upon completion of Beartracks bridge work and end of construction staging by Montana Department of Transportation (MDT) and Northwestern Energy (NWE) in East Caras Park. MDT has extended its lease for bridge staging through April 2023. Restoration for East Caras will occur in approximately May - August of 2023. MDT has paid funds for restoration of their staging area. Northwestern Energy is securing a land use agreement to provide for staging and siting a temporary substation in East Caras Park. NWE will reimburse the City its direct cost for site restoration for their impacts to the park, (\$~105K). Improvements @ Evelyn Borg Johnson Park and minor irrigation amendments and landscaping improvements may occur once the Beartracks bridge project nears completion. An additional upto \$10K of funds will be available for this projected from tree payments recieved by NWE.

**History & Current Status: Impact if Cancelled or Delayed**

The City has formally approved Rights-of-Way agreements with MDT that provide for \$70K as cost-to-cure and compensation for use of East Caras parklands for staging. These funds have been received by the City. Northwestern Energy's agreement terms provide for restoration of the balance of East Caras Site in 2023. The probable cost for NWE restoration is +/- \$110K. NWE has also agreed to pay for park tree losses needed to accomodate the temporary substation. Some or all of these funds may be used to plant new trees in East Caras. Cancellation or delay would affect public use of the parks as well as present public safety and liability concerns.

**Are there any site requirements/ Potentially Affected Interest (PAI) Coordination:**

MDT must ensure bridge work is completed and use of East caras for staging. Northwestern Energy's use of the East Caras properties is expected to be complete in mid/late spring of 2023 after which East Caras park restoration work can proceed.
