Thanks to the generous support of many local businesses and individuals, Parks and Recreation offers recreation grants to Missoula City and County residents.

Who qualifies for the Parks and Recreation Grant?

- Individuals or families who live in the City of Missoula or Missoula County and fall under the income guidelines.

City and County residents

- City residents are eligible for an annual grant up to \$320
- County residents are eligible for an annual grant up to \$160
- Grant funds may be used for Recreation Programs, Swim Lessons, or Aquatics Passes.

How to Apply For a Grant

1. Fill out the grant application included in this packet or [online](#). You need only one application per family.
2. Submit your Grant Application at Currents Aquatics Center and we'll process the application within a minimum of 3 business days.

Additional Information

- If the price of the program or pass is greater than the grant, the applicant will pay the difference.
- See the seasonal Parks and Recreation Guide featuring the latest swim lessons and recreation programs. The guide is published in March, August and December of each year and is available at www.missoulaparks.org.
- Parks and Recreation reserves the right to revoke admission to a facility, program, or activity for misuse or cause.
- Individuals who show extenuating circumstances will be considered for grants. Missoula Parks and Recreation will review requests on a case-by-case basis.
- **Group Homes:** Youth who are under the guardianship of a group home may apply for a grant if the client is low-income. Social Service agencies may send parents/guardians to parks to fill out an application.

City Residents: Lower your fees with a Resident Discount Card!

- Residents living within **City of Missoula** legal limits may apply for a Resident Discount Card. The Resident Discount Cards give customers up to 20% discounts on most recreation programs, pool passes, memberships and entrance fees.
- Bring a current bill with your physical address (water, power, cable or rental agreement) to Currents Aquatics Center. A staff member will confirm your city residency.
- You may purchase cards at \$2 each for each member of your household and can be purchased using Grant Funds. Cards are good from the time you purchase them until December 31 of the same year.
- You may only purchase Resident Discount Cards for people living in your household.

Income guidelines for families who do not receive public assistance

Individuals or families may qualify for grants if their income is at or below the levels shown below.
