2. Discussion of NS/WS Missoula Invest Health Walk around—Laval Means and Merry Hutton
 - Reviewed Healthy Neighborhood NS/WS survey results as a group, were surprised by some of the results (how many renters responded, how many residents identified themselves as depressed)
 - Laval Means explained how the funding for the survey allows them to look at the correlation between healthy environments and the long-term impact on the health of its residents. The next step is to develop a plan from the results for both long- and short-term goals. Will let us know the next steps and hope to engage community members on this.
