## Meeting Minutes

March 23, 2017  
Rattlesnake Market & Café

Attending - URNC leadership team: Doug Grimm, Hans Hoffman, Robin Carey, Bev Young, Andrea Stierle; Office of Neighborhoods: Jane Kelly, Karen Gasvoda

1. Approval of November 29, 2016 minutes. Hans moved and Robin 2nded to approve the minutes. All approved.
2. Support of large grant application, \$3000 from Office of Neighborhoods, to upgrade Rattlesnake Creek Trail: Robin Carey will prepare a grant application – submission in October - to upgrade parts of the existing trail, with the intent to eventually have an ADA (Americans with Disabilities Act) trail from Lincolnwood to Sawmill Road. Work will be concentrated along the section where there's a steep hill; the trail encompasses city, county and Forest Service lands. Grant will facilitate Parks & Rec regrading this to make it ADA accessible (not paved, but gravel cushioned). Robin is seeking county matching funds as well and has been in touch with Dave Strohmeier, County Commissioner. Robin would like for Dave to be at our general meeting and also wants to have a petition of support at our meeting. Bev moved, Hans 2nded, to give our support for this \$3000 grant application and put it on our agenda for general meeting.
3. Budget for URNC meetings: We only have \$392 remaining but we need ~\$408 for the general meeting mailing. We need to apply to the Office of Neighborhoods for reallocated funds (\$100). **Hans will apply online for this**. Previously we had approved to use \$700 of our budget for the Powerline West trail, along with the \$500 small grant that Robin received from the Office of Neighborhoods. **Robin will remind Morgan Valliant that we need to send Jane's office the \$700 invoice** to be paid by end of June. This \$700 does not carry over though the \$500 small grant does.
4. Plans for general meeting: Use county print shop, takes a week for printing and mailing by The Directory; then another 2 weeks for receipt by residents. Since there will be an election, bylaws require that there be at least a 10 day prior notification. Aim for Sunday April 30 at the Lutheran Church. **Bev will contact church**. 6:30-8:30 **Hans will prepare the postcard mailing, with Jane's office to provide template**. Elections are needed; Robin's spot is up for reelection and he's willing to continue.

We should open the meeting with information about ground rules for comments; also available grants for neighborhood projects.
