## **July 10, 2017 Meeting Minutes**

### **2. Safety & Transportation Issues:**

- 5th/6<sup>th</sup> Streets : including timeline for Council
- Higgins Ave Study Request for 4-3 Conversion

We have no updates on 5<sup>th</sup>/6<sup>th</sup>. We will try to have Gwen Jones and Ben at the next meeting. Discussion regarding the Higgins Ave. study, which the RFNC endorsed at the May 8 General Meeting, comments can be made until July 24. Budget Committee on the Whole is now considering the budget. Mary will ask Gwen Jones to put this on the “tickler list” for the meeting on July 12.

The next meeting of the Budget Committee is **Wednesday July 12, 10:10 am, City Council Chambers.**

We agreed to reach out to other LT members about going to the meeting, and representing RFNC, especially in terms of the motion we passed on May 8. Jonathan also noted the tie-in of this study with the Higgins Avenue Bridge reconstruction.

### **3. Safety issues on California St. (see attachment from Jane, July 5)**

Tod Gass is the MRA staff person working on the RFP and design for California. The RFP has not been issued. We assume that the RFP will include all elements of a Complete Street design (sidewalks, bike lanes, etc.). Although funding is not yet secured, the Agency must have a preliminary design. We will invite Tod or Chris Behan to the next LT meeting

Carla reported that the City and Police Department have been very responsive to the issues of speeding and safety on California, as discussed at the last LT meeting. Tickets have been issued, and curbs have been painted. It has made a big difference. Good News!

### **4. Willard School Rebuild & Planning Process**
