MINUTES

- 1. Attendance and Introductions:** FV-PC LT: Ray Aten and Cathy Nolan present; Mary Barnett, John O'Connor, Mary Marry, and Wayne Heitt absent. Office of Neighborhoods: Karen Gasvoda. Neighbors: Barb Seekins and PJ DelHomme.
- 2. Accept/Modify Agenda:** Accepted as modified.
- 3. Approve Leadership Team Minutes - August 3, 2017:** Minutes were approved by voice vote.
- 4. FV-PC Fund Balance:** Ray reported the fund balance was about \$560 and if additional funds were required the neighborhood could apply to Community Forum for re-allocated funds.
- 5. Plan Next FV-PC Neighborhood Council meeting:** Meeting topics and locations were discussed. At the conclusion of the discussion the decision was to delay until early in 2018.
 - a. Topics:**
 - i. Review and update the Neighborhood priorities – The present priorities were discussed.
 - ii. An update on the Whitaker Park USFS radio building – Ray noted the Donna Gaukler (Parks and Rec) was not prepared to present an update: “Given the condition of the building, which is poor and out of ADA compliance, the possible interest by others (local museums) in moving the building to a museum grounds and restoring it for interpretation/education, and the interest of the neighborhood in adding a picnic shelter, Parks and Recreation will gather numbers and options for the Building. Once we have more information, we will share that with the neighborhood.”
 - iii. Approval of the Farviews-Pattee Canyon Tree Plan – Ray presented the list of trees selected by the attendees at the September 7, general meeting and noted that a draft tree plan is not yet available.
 - iv. Presentation by Missoula’s Code Compliance Officer (Carmell Owens).
 - v. Presentation by PJ DelHomme of his vision for Ninkpata Park with the intention of gathering support from the neighborhood and Parks & Rec. – PJ reviewed his vision and subsequent discussion included park boundaries, park signage, park elements, applying for a Neighborhood Project Fund grant, and next steps.
