1. Welcome and Introductions – No new attendees
2. Approval of the minutes of June 9, 2018 minutes - approved.
3. Treasurer's Report- Discussion on how to spend the remaining \$ 397.11 left in funds. Motion to buy two trees for Bellevue Park with the funds - passed.
4. Bellevue Park – Mark: old existing well at park had underground sprinklers that froze and are not serviceable. Need to located original well/well log. Contact City Water? Jane will look for the contract park survey (Territorial Engineering) to see if there is a call to a well on the plat.
 - a. Boyd. Need a Port-a-let for this summer – Mark will follow-up by next meeting on Port-a-potties for Boyd and McLeod.
6. Street and Sidewalks – (Pothole locations) – Each SGT member asked to submit 10 potholes to city. This can be done via City web page.
7. MRL Park Update – Kelly Lloyd – Work is going full scale. They upgraded ground testing process to above residential standards. Trail is paved and ready for use. Pedestrian crossing light has yet to be installed.
8. Cowboy Flats and 39th St. Updates – Bob Martin – How much funds will be available for Bellevue Park?
9. Public comments on non-agenda items – no commentators.
10. Office of Neighborhood Reports – Jane: They have a work study student – "Sylvia". Stories in Stones – Sept. 16th at old Missoula Cemetery. Sunday Streets - Sept. 9th.
