1. The May 2, 2018 leadership team meeting minutes were approved.

2. Calming District Update - Ben Weiss gave additional information on the counts for the calming the Calming District discussion on the circles, crosswalks and street signage. Crosswalks need at least 15 people crossing daily to warrant the striping, not enough traffic to warrant new crosswalks. There are several crosswalks on Bancroft near Sentinel High School and Splash Montana. The crosswalks on SW Higgins at Agnes Street and South Ave, as well. Reminding families of current crosswalks would be good. South Avenue has a crosswalk on Queen. Mountain Bus Lines will be changing the bus stop to be in front of Drum Brothers Coffee, which will help with visibility of the crosswalk. Because of the low crash numbers with injuries no additional signage will be warranted.

With people being still interested in the calming circles, Dave Westfall made a motion that the neighborhood Leadership Team pursue the next steps in determining the formal procedure for the calming district. Jerry Dillinger seconded and the vote was unanimous.

Dave with the help of Ben Weiss will begin working on the forms and preparing for the next steps, which is to gather signatures from the residents, can be renters and homeowners. This can be done at the general meeting and if more are needed, a door to door campaign for the 100 signatures required. City engineers will look at the area to establish the exact cost per circle. There are many ways for people to pay, 1 year to 20 years.

3. Bancroft Ponds Park update – Dave Westfall will have the newest version of the Ponds' working document available on Monday June 11 to be posted in the neighborhood's online information. Lots of information has been added concerning the environment and management of the pond.

Colleen reminded the team that she will be attending the large grant (\$3000.00), information class in September and the committee may want to discern what project(s) they would like to be funded. Outdoor classroom and the kiosk were mentioned. Besides the Missoula Neighborhood's grants there are numerous other ways to help fund the park. Pat Collins suggested New Fields, besides the Clark Fork Coalition and the Wild Life Federation for matching funds or grants.

Colleen asked Jane to check with United Way concerning their Volunteer Day to see if they could come to the Pond to help with Spring Clean-up from 1-4pm on Friday, June 22.
