

**Farviews – Pattee Canyon Neighborhood Council  
General Meeting Minutes  
Thursday, July 12, 2018, 5:30 PM  
Whitaker Park (Corner of 39<sup>th</sup> street and Whitaker Drive)**

Ice Cream (Wilcoxson's Huckleberry Ice Cream Sandwiches) was provided by Farviews – Pattee Canyon Neighborhood Council and the Office of Neighborhoods beginning at 5:30 PM.

PJ Delhomme opened the meeting at about 5:50 PM with the introduction of Ray Aten, Cathy Nolan, and Julie Aldegarie of the Farviews - Pattee Canyon Leadership Team, Jesse Ramos, Ward Four City Council Representative, and Officer Ethan Smith, Missoula Crime Prevention. Attendance: headcount - 38; sign-in sheet - 34

Ray Aten requested approval of April 5, 2018 general meeting. A motion for approval was seconded and passed by a unanimous voice vote.

Ray Aten presented the expenditures for the 2017/2018 neighborhood council, noted that there was a expenditure over-run of \$2.03, and noted that the 2018/2019 allocation commenced July 1, 2018 and will be approximately \$1500.

Officer Ethan Smith and Tony Rollin, chair, Missoula Neighborhood Watch reviewed the purpose and structure of Neighborhood Watch and encouraged neighbors to attend the general meeting on September 18, 2018 at 7:30 pm in the Jack Reidy Room, City Council Chambers.

PJ Delhomme presented an update on Master Park Planning for Ninkpata and Whitaker Parks and invited all to a Park Design Workshop to help plan for the future of Whitaker and Ninkpata Parks. The Park Design Workshop will be held on Wednesday, September 12, from 5 - 8:30 PM at the University Congregational Church, 405 University Ave.

PJ Delhomme reviewed the Safe Routes to Lewis and Clark Elementary School and encouraged all to consult the Safe Routes to School plan on the Missoula County Public Schools website.

Ray Aten presented the revised Farviews - Pattee Canyon Neighborhood Council Bylaws prepared by the Leadership Team using the Office of Neighborhood's template and reviewed and approved by the City attorney. After a short discussion about the necessity of having bylaws the bylaws were approved by a unanimous voice vote.

Ward 4 City Council Representative Jesse Ramos spoke about the budget review process that is before City Council and addressed questions from the meeting attendees. Several questions and comments were about the urban deer population and potholes.

There was no further public comment.

PJ Delhomme announced that the Barmeyer Loop Trail is open and well used. An attendee noted that the public should use only the parking lot and not attempt to park along the side of the road.

The meeting was adjourned at about 7:30 PM.
