1. Sarah Nesci, an AmeriCorps Volunteer for Recycling Works Inc. was introduced to the Leadership Team Members.
2. January 2, 2019 Minutes were approved as posted.

Jeff Lamson will be the presenter for Lewis & Clark and will speak on the trails and birding projects at Bancroft Ponds. Kathleen Hanson is going.
