Terry Conner moderated the meeting.

1. All attendees were welcomed and invited to introduced themselves.
2. A forum was established.
3. Approval of the September 1, 2021 Leadership Team Minutes as posted.
4. Ben Weiss, Senior Transportation Planner discussed the calming circles and the stop signs to be implemented from Benton to Park. Many residents were interested in what is going to happen. Discussion was held concerning line of site at intersection, will people stop and a police presents to issue warnings/tickets to violators. The plan will be implemented, but residents will need to say if this plan is working.
5. Joint Traffic Safety Committee Plan of Action – Jeff reminded the group that there will be more work to be done with South Ave.
6. Bancroft Ponds Major Updates –John Conner
  1. **Trails:** Small reserve of money held for future maintenance, probably adding gravel to thin spots next spring or early summer. Re-evaluate in the spring.
  2. **Interpretive Signs:** The \$6k project fund that was questioned at the September LT meeting has been restored to the project budget. The city-wide signs and trailhead improvements project is scheduled to go out for bid late this year. Installation dates are not yet determined but are tentatively scheduled for next year. Our input on sign design was reaffirmed in a recent email from Jeff. The L&C design consultant people designated in the grant application will be contacted when required.
  3. **Outdoor Classroom:** No money has been spent to date. We are still waiting on Jeff Gicklhorn for seating stone pricing and a delivery schedule. Stones may be delivered to the park in the next few weeks and staged for later installation. Placement will be when Parks resources are available, possibly very late in the year after weather has closed other projects. No volunteer involvement will be required. Outreach to schools will be scheduled after the stones are placed.

7. Newsletter update – Kathleen Hanson reported that information is being gathered for newsletter.
8. Community Forum Report– Colleen Biehl reported that Colin Woodrow has resigned.
