Approve meeting minutes for August 8, 2021 – Held until January meeting.

Public Comment –

Lolo Street/Missoula Ave. intersection: Ike shared that he and his wife have been monitoring the crosswalk on Lolo Street and the vehicle, pedestrian, and bicycle traffic Monday – Thursday during heavy use periods when kids are going to and from Rattlesnake School. The advisory speed limit is 15 mph through the crosswalk but they observed many vehicles that appeared to be speeding. The crosswalk was not repainted this past summer. Both Ben Weiss and a city engineer have been contacted.

The committee will place this item on the agenda for the next meeting and also ensure that the issue is addressed in the transportation plan.

Looking ahead for improvements during the 2022 City of Missoula construction season

The Lolo Street/Missoula Ave. intersection safety issue including the possible use of speed tables, traffic calming circles, rumble strips, caution signs, etc.

Public comment

Bill mentioned that positive progress has been made with most of the property owners along the route of the Borrow Trail (Upper Rattlesnake Drive from Creek Crossing to the city limit). Two owners near the curve are not yet on board due to concerns over trash and parking.
