- The Missoula Redevelopment Agency has opened up the Johnson St. Shelter location for development proposals. - Community Forum report from Clint. Parks and Rec has completed their PROST with the final report on a 10-year plan to be released in the Spring. Public comment remains open. Our Missoula Project draft land use plan will have events throughout the month of October for public comment and education, most of which will take place at the Missoula Public Library. Plan is projected to be finalized next Spring.

- Discussion regarding reaching out to Parks and Rec regarding the National Wildlife Federation sign deferred to next meeting
- Neighborhood report to City Council will take place Monday October 28th, Jenn will present. Topics to include Block Party report, Neighborhood Action Plan, and Neighborways.
