 - a. Brainstorm Future Agenda items
 - i. Kalina checked in with Parks and Rec after the last meeting and they were not able to come to the December meeting. Ninkpata park does not currently have any movement on it. Kalina will reach out again to have them in the future to get more information about the parks in the neighborhood.
 - ii. Deer. Kalina notes this is definitely a topic of interest for every neighborhood and has been trying to figure out where it is at. Fish, Wildlife, and Parks (FWP) has had some information but has not connected with city council recently. We can see if FWP or City Council to come talk about it at a future meeting. A member of the team was wondering about the Deer study that was suppose to happen. Kalina informs the group there was a deer study right before the pandemic but it was mostly regarding the perception of Missoulians on the issue. To move forward her understanding is there needs to be a deer count in the city and an updated study of Missoulian's perceptions regarding solutions moving forward. A member asked about Helena's deer population solution. Kalina informs the group that Chronic Waste Dieses has been a large reason the city has acted on their deer population.
 - iii. Speeding in the neighborhood. Team would like to invite a transportation planner to a future meeting.
 - iv. Whittiker Park- Large tree fell. Want to know the time frame of the fenced off area reopening.
 - v. Northwestern Energy project kind of loud. Julie can talk with the service engineers and will check back in with the group.
 - vi. New 28 plot subdivision was going in in the NH, used to be the water company land and now the city absorbed the land when they took over the water. Not sure the movement on this.
