- Michael Hicks, project Manager from the Missoula Redevelopment Agency (MRA) gave an update on the evolving plans for the MRL Triangle property. MRA will be seeking approval from the City Council later this week to begin the process of hiring a consulting firm to lead a public engagement process regarding the future of the property. They are anticipating at least 9 months of a discovery phase, and Mike will reach out to the Leadership Team with updates. The Team has offered to assist in engaging the Neighborhood in discussion of the property at the appropriate time.
