Motion: The committee recommends the City Council consider a resolution declaring the official intent of the City of Missoula, Montana to reimburse certain original expenditures related to the acquisition of certain capital equipment from the proceeds of tax exempt bonds to be issued by the City of Missoula, Montana after the payment of such original expenditures.

Brent Ramharter, Finance Director, said with this resolution we are complying with IRS regulations to disclose our intention to reimburse ourselves with tax exempt bonds for energy conservation projects approved by Council last week. We indicate we will reimburse ourselves up to \$1 million in costs, which should cover the maximum amount of projects undertaken.

Ed Childers moved to approve and requested the payback info is included in the referral and resolution.

Mr. Ramharter said he would provide the 15 year [cash flow sheet](#).

Jason Wiener asked when we bid the projects.

Mr. Ramharter said the projects are being bid in phases, the prices will be locked in by Johnson Controls and once that is confirmed, we will proceed with selling the debt.

Mr. Wiener asked if we do this process with SID's.

Mr. Ramharter said yes.

Mr. Wiener asked what would happen if the projects weren't done.

Mr. Ramharter said nothing; there would be no debt to sell.

Pam Walzer asked if the \$96,000 per year loan payment is for the Energy Performance Contract.

Mr. Ramharter said yes, and this resolution will get everything in place.
