2. Discussion of the Sonoran Institute Study – [Russell Street Development Recommendations](#) - Kim Walterskirchen summarized the study and its findings. The recommendations seemed to be focused on mixed use and higher density. Also making the Russell Street corridor more like a downtown with a more diverse mixture of use (light manufacturing, retail, housing, etc.) They suggested talking to current local businesses to see if some small changes could be made, like making the outdoor seating area at Bayern Brewing more inviting (currently there is a privacy fence).
