Summary of Agenda Discussion Items

- **Phase I 95% Drawing Review and Bid Schedule Update**

Neil M. updated OT on the 95% phase I design review with TLG and phase I bid scheduling. TLG was in town January 7-8th to review City/County comments. TLG is working to have the phase I construction document set updated to reflect comments by January 27th, 2016. TLG and JCG are coordinating the distribution of phase I bid packages to best accommodate the ability of local contractors to submit. Bids packages are scheduled to be released January 31st - February 7th, 2016. Submittals will be due 3 weeks after posting. Bids could be awarded as early as February 24th, 2016 pending release of bid packages. While phase I bids are out, construction document development will resume on phase II.

JCG is expected to deliver an updated phase I cost estimate anytime. It is predicted that phase I cost estimate will be ~ \$3 MM under the original DHM estimate of 20.2 MM. Portions of phase I went to phase II construction. To meet budget, phase I structures and site elements were reduced/eliminated knowing that phase II scope of work would increase from the original DHM plan.

Late February after bids are confirmed, financial design decisions will be decided for phase I and the construction budget for phase II solidified. There are currently 6 bid-alts for phase I.

- Jackson Prime Contract Change Order Revision Approval
 - 005 Bid Package #2 – Procurement, Fabricate, and Deliver Pavilion Log Structure
 - Review and Approve JCG recommended amount for Bid Package #2, Bos Log Builders, in the amount of \$110,097.60

Neil M. reviewed the three bids that JCG received for the procurement/fabrication/delivery of logs for the pavilion log structure. JCG recommends Bos Log Builders with a base bid price of \$103,564.50 with a grand total of \$110,097.60 with fees and insurance. A separate contractor, unknown at this time will erect the pavilion.

Barbara Berens asked for a motion to authorize JCG's recommendation that Bos Log Builders fabricate and deliver the pavilion log structure at an expenditure of \$110,097.60. John Wilson made the motion, Andrew Czorny seconded the motion. Motion passed unanimously.

- **Other Items**

Neil reminded the team that OT meetings are the 2nd and 4th Wednesday of the month. The next OT meeting will be January 27th, 2016. Donna G. suggested that a tentative OT meeting time be blocked out March 2nd, 2016 @ 11:00 AM as a backup to February 24th, 2016 to possibly review and award phase I bid contracts. Barbara Berens will be out February 24th, 2016.

Donna G. identified February 24th, 2016 as a goal to have an updated FMRP all cost estimate. Andrew C. will provide an updated financial report for the project as well, date TBD.
