Ben will be meeting with businesses and residents on 5th and 6th that will be impacted by any adjustment. He will be fielding requests from these individuals to pass along to the consultant for incorporation of the design. Ben hopes to have interviews done this month and the report ready for next month.

Gwen reviewed highlights from the council meeting and shared that the motion passed was that (paraphrase) staff will develop a preferred alternative based loosely on 1C after input from business and property owners along the streets while keeping costs as low as possible.

Long Range Transportation Plan and Master Bike Plan are currently open for comment on www.activatedmissoula.com until February 10th.

Caleb motioned (Mary seconds) that a member of the leadership team will write a letter to the MPO (Metropolitan Planning Organization). The group authorizes Caleb to write on our behalf with the following items

- re-categorization in the LRTP for 1C
- allowance for a future 2 way conversion for the streets

There was unanimous approval from the group for this motion.

Gwen shared that the Missoula International School (MIS) has purchased the property on 3rd street. MIS met with Missoula Park & Rec to propose a partnership regarding a Community Center used by the city in the off hours of MIS operation.

There was study done regarding this partnership and it showed a community center run by the City of Missoula could sustain on its own however it would not generate enough income to pay the rent to MIS for the space. It is unlikely for a partnership to develop between MIS and the City for a community space.

The focus has now shifted for building a Community Center behind Currents.
