1. Homeward – Affordable Housing Property in the Old Sawmill District – Andrea Davis, Executive Director

The non profit development organization Homeward has received approval for low income tax credits which will enable the development of a 26 unit affordable housing project in Silver Park. Ground breaking is planned for fall 2015, with leases beginning in the winter of 2016. Features of the project include:

- 6 studios; (11) 1 bdrms, (3) 2 bdrms; (6) 3 bdrms
- affordable rents: \$354- 740
- underground parking
- sustainable building and energy efficiency

There will be a public meeting on design on May 26. A representative from Homeward will attend the June 10 RF General Meeting.

2. Report: April 29 Meeting with Council persons Fireworks Scheduled at Osprey Stadium Next Steps

Councilwoman Emily Bentley spoke with the Mayor and Matt Ellis of Playball Missoula. Next step is for RFNC (Riverfront Neighborhood Council) Leadership team to meet with Matt. Jonathan, Emily & Mary will attend, as well as Mike Painter. We will seek attendance from Dale McCormick and Gwen Hoppe.

3. Traffic Calming: Bob Giordano 5th/6th Street Traffic Calming Update if needed Higgins Ave. Issues & Discussion

Alex Taft successfully inserted funds for an engineering study for 5th/6th Street! The budget year is July 1. It is likely that Ben Weiss will be a key point person. The LT (leadership team) emphasized the importance of reviewing the RFP (Riverfront

Proposal) before it is released to ensure the scope of RFNC concerns and history on this issue. Caleb will take the lead and represent the LT on this.

Bob presented an overview of a proposal to calm traffic, improve safety and friendliness for bikes and pedestrians. The overall concept is to convert 4-lanes of auto traffic to 3. His power point slides illustrate the concept, its benefits, and the track record of this in Seattle, where 40 of such conversions have been a success. Higgins Ave, from Broadway to Brooks, intersects our neighborhood.

The following motion was presented by Jonathan:

The Riverfront Neighborhood Council Leadership Team endorses and supports continued formal study of the MIST proposal. Mary seconded the motion, and it was unanimously passed. This will be presented at the upcoming general meeting with a request for full neighborhood support.
