RESOLUTION NUMBER 7444

RESOLUTION RELATING TO SPECIAL IMPROVEMENT DISTRICT NO. 544, COMMONLY KNOWN AS THE RATTLESNAKE VALLEY SEWER PROJECT; CREATING THE DISTRICT FOR THE PURPOSE OF UNDERTAKING CERTAIN LOCAL IMPROVEMENTS AND FINANCING THE COSTS THEREOF AND INCIDENTAL THERETO THROUGH THE ISSUANCE OF SPECIAL IMPROVEMENT DISTRICT BONDS SECURED BY THE CITY'S SPECIAL IMPROVEMENT DISTRICT REVOLVING FUND

BE IT RESOLVED by the City Council of the City of Missoula (the "City"), Montana, as follows:

Section 1. Passage of Resolution of Intention. This Council, on June 15, 2009, adopted Resolution No. 7173 (the "Resolution of Intention"), pursuant to which this Council declared its intention to create a special improvement district, designated as Special Improvement District No. 544 of the City (the "District"), under Montana Code Annotated, Title 7, Chapter 12, Parts 41 and 42, as amended, for the purpose of financing the costs of certain local improvements described generally therein (the "Improvements") and paying costs incidental thereto, including costs associated with the sale and the security of special improvement district bonds drawn on the District (the "Bonds"), the creation and administration of the District, and the funding of a deposit to the City's Special Improvement District Revolving Fund (the "Revolving Fund").

Section 2. Notice and Protests.

2.01. Notice of passage of the Resolution of Intention setting forth the date for a public hearing and the period of time in which property owners could file written protest against the District and the Improvements was duly published and mailed in all respects in accordance with law (the "Notice"). The protest period established in accordance with Section 7-12-4110, Montana Code Annotated expired at 5:00 p.m. on July 6, 2009. (the "Protest Period").

2.02. Within the Protest Period, three (3) protests were filed with the City Clerk by the owners of property in the District subject to assessment, representing 0.9% of the total estimated costs of the Improvements and costs incidental thereto to be assessed against the properties in the District, in accordance with the method of assessment in the Resolution of Intention. At its meeting on July 6, 2009, the first regular meeting of the Council following the expiration of the protest period, the City acknowledged and passed on the protest.

Section 3. Public Hearing. On this day, July 13, 2009 and in accordance with the Notice, this Council has conducted a public hearing on the creation of the District and the making of the Improvements and has afforded all members of the public the opportunity to speak.

Section 4. Excluded Property, Adjustments. The Resolution of Intention identified four parcels of land, the owners of which elected to have excluded from the District (the "Excluded Property"). Subsequent to the adoption of the Resolution of Intention, the owner of the parcel of land located at 2524 Sycamore Avenue, Missoula, Montana and more particularly described as Lot 32, Orrsdale Addition (the "Property") has executed and delivered to the City a Request for Inclusion in City of Missoula Special Improvement District No. 544 and Consent to Assessment for the Improvements (the "Request and Consent") requesting that the Property be included in the District and that it be assessed for the costs of the Sewer Main Improvements and the Service Line Stub as specified in the Request. Based on the Request and Consent, the District shall be created in the amount of \$2,028,090. The boundaries of the District are hereby revised to include the Property as shown on the Revised Exhibit B attached hereto. The assessment list is hereby revised to include the Property and the assessment to be levied against it as shown on the Revised Exhibit C attached hereto.

Section 5. Creation of the District; Insufficiency of Protests. The Council hereby confirms that the protests against the creation of the District and the making of the Improvements filed during the Protest Period, are insufficient to bar creation of the District. The District is hereby created on the terms and conditions set forth in, and otherwise in accordance with, the Resolution of Intention, except as modified in Section 4 hereof. The findings and determinations made in the Resolution of Intention, including, without limitation, those relating to funding the Revolving Fund and securing the Bonds thereby, are hereby ratified and confirmed.

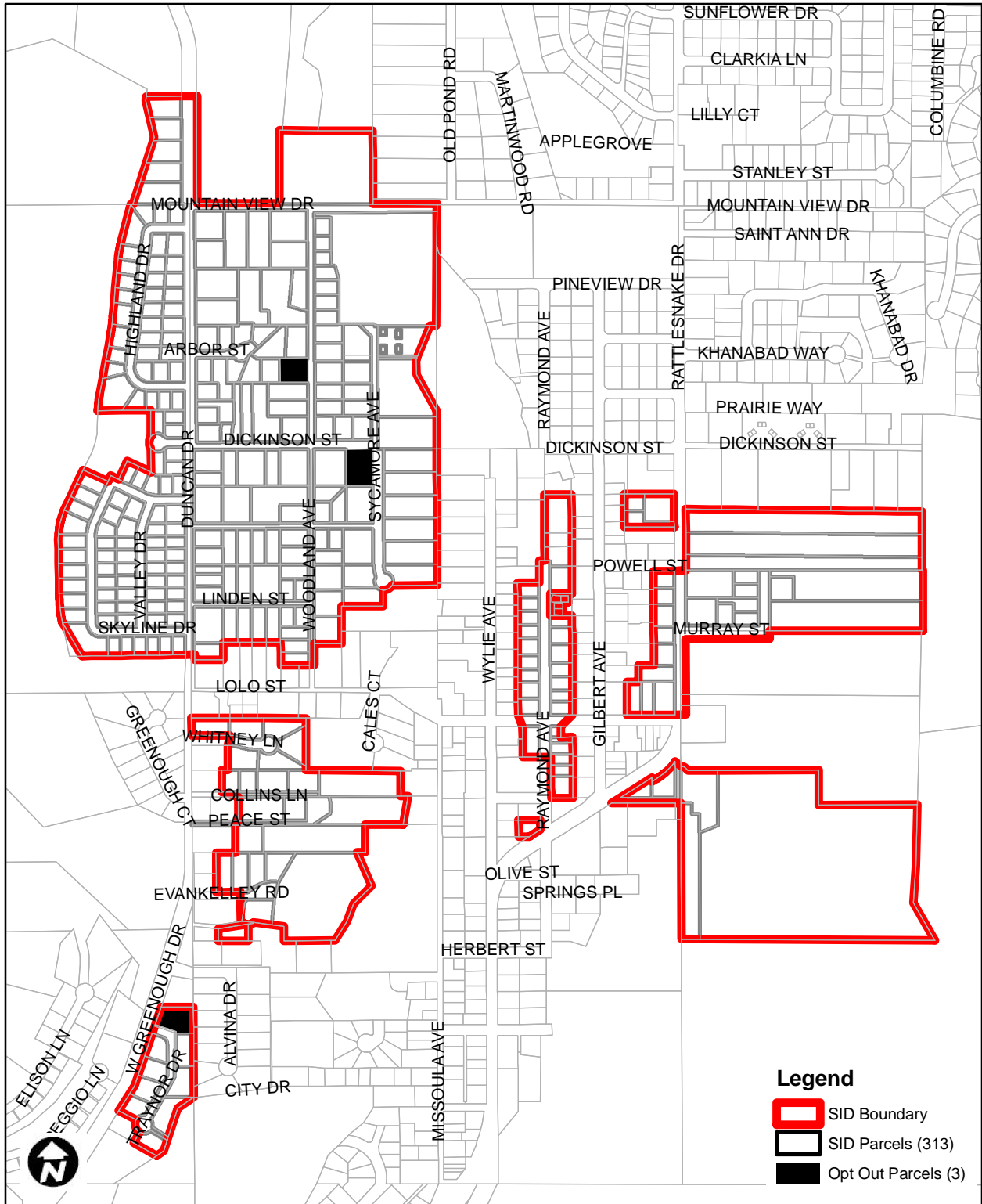
