Description and justification of project and funding sources:

Parks and Trails bond provides for \$1,000,000 to renovate, upgrade and develop up to 12 playgrounds throughout the City. Staff will seek to use bond funds to leverage other sources such as CDBG grant Park Impact Fees, and Fees in Lieu to the extent funds are available for playgrounds.

The PT bond playgrounds were selected to maximize potential benefit to the community. Locations selected serve 51% of all family households within 1/2 mile of the park sites. The playgrounds will also serve approximately 53% of the City's residents between ages 2 to 14 years..

Parks and Trails bond playground upgrades are planned for: Bonner, Franklin, Greenough, McCormick, McLeod, Northside, Pleasant View, Rainbow, Skyview, Wapikia, Whitaker, and Playfair (if sufficient funds are available) see map

Pleasant View park will receive a new playground which will require additional operating expenses to maintain consistent with public safety standards, playground safety codes and to provide an acceptable level of maintenance for user satisfaction. The bond will provide for replacement of existing sand/sawdust fall zone material in favor of Engineered Wood Fiber (EWF) at 10 playgrounds. EWF meets ASTM standards for fall zone protection, is ADA compliant, and is more expensive to supply.
