Continuation of the URD III Residential Curb & Sidewalk Project to construct missing sidewalks on Benton, Fairview & Dearborn Avenues between Eaton & Clark Streets. This area was recently brought into URD III through a boundary modification to include this neighborhood which was excluded from URD III when it was created in 2000. The neighborhood immediately to the east has already received new sidewalks and private investment is occurring as a result.
