The planned reconstruction of Russell Street has caused evaluation of the existing 30" diameter Broadway Interceptor sewer line. The existing sewer line is planned to be reconstructed for approximately 75 feet. Both the upstream and the downstream portions of this interceptor were previously reconstructed. This portion was not included in that project due to the disruption of traffic on Russell Street. This project will be completed in conjunction with the reconstruction of Russell Street in construction season 2017.
