SPORTSMANSHIP AGREEMENT - (ALL PLAYERS MUST READ AND SIGN)

THIS AGREEMENT IS TO BE SIGNED AND UNDERSTOOD BY ALL PLAYERS, AND IF NOT ADHERED TO, WILL RESULT IN DISMISSAL FROM PARKS AND RECREATION PROGRAMS, NO REFUNDS.

- 1) **NO FIGHTING** - ANY PHYSICAL FIGHT DURING GAME PLAY WILL RESULT IN THE DISMISSAL OF ALL PLAYERS INVOLVED FOR THE SEASON.
- 2) **ZERO TOLERANCE POLICY** - REGARDING VERBAL ABUSE OF PARKS AND RECREATION EMPLOYEES; INCLUDING OFFICIALS, UMPIRES, SUPERVISORS, ETC.
- 3) OFFICIALS DECISIONS ARE FINAL DURING GAME PLAY; DISPUTES AND CLARIFICATION OF RULES MAY BE ADDRESSED BY TEAM CAPTAINS AT HALFTIME OR END OF GAME.
- 4) ALL PLAYERS MUST ABIDE BY ALL RULES STATED IN SPORT SPECIFIC RULE SHEET.
- 5) PLAYERS ARE EXPECTED TO BE RESPECTFUL TO EACH OTHER AND PRACTICE GOOD SPORTSMANSHIP TOWARDS ALL OFFICIALS, PLAYERS, TEAMS, AND SPECTATORS WITHIN THE LEAGUE.
