

Cancellations/Postponements through April 30

Thank you for choosing Parks and Recreation and Currents Aquatics Center. We hope you and your family remain healthy and safe during these difficult times.

To protect public health and safety in light of the COVID-19 pandemic, we have cancelled or postponed the programs listed below through April 30. The City of Missoula is working closely with the Missoula City-County Health Department to prevent the spread of COVID-19.

Credits/Refunds

You are entitled to a full refund or credit when Parks and Recreation cancels a program. We will automatically credit your Parks and Recreation account for the full program fee, and send you a credit receipt via email or mail. The credit may be used for any recreation program, or for swim lessons, admission and purchases at Currents Aquatics Center or Splash Montana.

Social Distancing

We have no evidence to suggest that any Parks and Recreation facility or staff has been exposed to COVID-19. However, the [CDC](#) recommends that community-based interventions such as event cancellations, social distancing, and facility closures can help slow the spread of COVID-19. As the coronavirus spreads throughout the nation, our local response becomes even more critical as we work together to protect each other and the most vulnerable among us.

In addition, the City Life Gym is closed, facility rentals are canceled, and most recreation and aquatics programs are suspended through at least April 30. Closures and program cancellations may be extended to protect public health.
