

## **Community Organizations Active in Disaster (COAD) Summary Sheet**

**Monday, April 13, 2020**

Missoula Community Organizations Active in Disaster (COAD) has mobilized to identify, assess and meet community needs that are outside the scope of the COVID-19 incident management team. Missoula's COAD currently includes six task forces addressing key areas of concern: **Economic Recovery, Food Security, Mental/Behavioral Health, Volunteer and Donations Management, Childcare, and Homelessness**. This summary sheet will provide updates on the progress of these task forces.

### **Economic Recovery**

The task force has developed a four-step TEAM approach to navigating the current situation for businesses experiencing impacts due to COVID-19. These steps are designed to give businesses simple and clear guidance to ensure the health and safety of employees and access to available resources. The task force has enlisted the help of the University of Montana to quickly establish the Business Emergency Assistance & Recovery, or BEAR, Program. The BEAR Program is organizing navigators to advise businesses that do not have established relationships with dedicated professionals about resources created by the CARES Act. ### **Childcare**

### **Mental/Behavioral Health**

### **Food Security**

The food supply at local pantries is stabilizing; however, food pantries are continuously requesting financial contributions to ensure a consistent supply of food. Food distributors, like Meals on Wheels, need PPE for their delivery drivers. Financial donations can be made to United Way or to the individual food bank by accessing their website.

### **Homelessness**

The homelessness task force is working side by side with the health department to ensure critical COVID-19 messaging is reaching this population. Contingency plans are being formulated for shelters, and financial and housing assistance is being sought to limit the spread if an individual tests positive.
