### Day Cares/Group Reservations during public swim hours

#### Option 1: Make a Recreation Swim reservation in Pond/River/Slides area:

- No private rentals in pond/river/slides area during public swim.
- Groups may make a Recreation Swim reservation for each person in the group; there are 50 spots available for each session. Session times above.
- Contact Aquatics Manager Eric Seagrave: [parksrec@ci.missoula.mt.us](mailto:parksrec@ci.missoula.mt.us) at least 1 week in advance.
- Groups may book **one** Recreation Swim session per day.
- Regular admission rates apply.

#### Option 2: Reserve the 50-meter pool, east end

- 1.5-hour sessions, available daily 12 to 5 p.m.
- Rate/1.5 hour session: \$75 for up to 25 people; \$150 for up to 50 people.
- By order of City-County Health Dept., your group is restricted to the east end of the 50-meter pool.

### After Hours Rentals, 1.5-hour sessions

- Rent the pool after public swim: Mon – Fri: 8 to 9:30 p.m., and Sat & Sun: 6 – 9:30 p.m.
- Pond/River/Slides: \$240 for a 1.5-hour session.
- Pond/River/Slides **Plus 50m Pool**: \$360 for a 1.5-hour session.
- Maximum of 50 people at either rental.

## Group Swim COVID Safety Information and Procedures – Splash Montana and Currents Aquatics Center

**PAYMENT/CANCELLATIONS:** Please call 721-PARK (7275) if you are unable to attend your session so that we can offer it to another group.

Missoula Parks and Recreation’s Aquatics Program is implementing these safety protocols at the order of public health officials to prevent the spread of COVID-19. We appreciate your patience and cooperation in following these guidelines.

**The danger of contracting COVID-19 exists if you choose to enter this aquatic facility.**

1. DO NOT enter the facility if you have a cough, fever, or other symptoms of illness.
  - a. Daycare Providers MUST confirm that the children they bring and the staff who bring them are not exhibiting symptoms.
2. Maintain at least six (6) feet between you and any other people who are not part of your immediate household.
3. Wear a face covering when you are not in the pool. **NEVER wear a face covering in the water.**
4. You are responsible for washing your hands as well as any object/s you bring into this facility.
5. Face masks required in locker rooms. Come dressed to swim.
  - a. Whenever possible, dress and change outside of the facility.
  - b. **Lockers will not be available. DO NOT bring valuables into the facility.** Bring your belongings onto pool deck.
  - c. If you must change at the facility, dress in showers or changing stalls. Do not change in common areas.
  - d. Locker rooms will be monitored for crowding.
6. You may be directed to exit the facility via a door/gate OTHER than the one you entered. Please ask Staff if you are unsure which way to exit.

### **Please check that you agree to the following:**

**YES**, I understand my group must pay admission or use a punch card or pass at the pool to attend Recreation Swim.

**YES**, I agree I WILL NOT visit City aquatics facilities or bring any person to the pools if I/they have ANY of these symptoms, or have been exposed to a person who has tested positive for COVID-19:

Fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea.

**YES**, my group agrees to wear a face covering in the entrance gate area/lobby, locker rooms and whenever we cannot maintain a 6’ distance from others. We will not wear face masks in the pool.

**WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19  
ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT**

In consideration of my rental with the City of Missoula Parks and Recreation Department and those events and activities related to my rental, the undersigned acknowledges, appreciates, and agrees that:

1. Permit Holder, to the best of their ability, will adhere to all regulations set forth by the State of Montana and the Missoula City-County Health Department relating to best practices to reduce and eliminate the spread of the COVID 19 and other communicable diseases. Permit Holder agrees that participation in the activities being hosted by City of Missoula Parks and Recreation may include possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. PERMIT HOLDER KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for those invited and registered through Permit Holders Organization to participate; and,
3. Permit Holder agrees to comply with the stated and customary terms and conditions for participation with respect to protection against infectious diseases (“best practices”). If, however, the Permit Holder observes a guest, participant or member who’s behavior poses a significant risk to the other guests, participants, or members, including non-compliance with best practices set forth by the State of Montana, the City of Missoula or the Missoula City/County Health Department regulations, Permit Holder agrees to re-educate their invited guests, participants, or members. If Permit Holder cannot gain compliance, Permit Holder agrees to have that guest, participant or member removed or banned from the activity for a period of time deemed appropriate by Permit Holders governing body, and to inform Facility Manger of the behavior and action taken to mitigate the unwanted risk to other participants and/or guests; and,
4. The PERMIT HOLDER hereby indemnifies and holds the City of Missoula and Missoula County harmless of and free from any and all loss, damage, ILLNESS, DISABILITY, or DEATH to any person or property, arising from any cause or for any reason in or about the described facilities ; the PERMIT HOLDER further agrees to waive all claims against the City or the County on account of any loss, damage, injury from whatever cause which may occur to it and its property in the use and occupancy of said described premises, the giving of this waiver being one of the considerations upon which this General Rental Permit is granted.
