Permit Not Required for Individuals or Groups ≤ 6

Impromptu or with facility rental

***Restrictions-** must be a minimum of 100 feet away from any residential housing

Plainly audible sound needs to dissipate at a distance greater than 25' from its origin

Sound origination must be located no closer than 25' from edge of curb or sidewalk

Time Restrictions: Memorial Day-Labor Day (Mon-Thurs 11:00am - 8:00pm) (11:00am - 9:00pm
Fri-Sat) All other months (Mon-Sun 11:00am - dark or 7:00pm, whichever is earlier)

Amplification not permitted during school hours if park is adjacent to a school

Time duration does not exceed 1 hour

Type P4 - Permit Required

Neighborhood Park with restrictions from Type P3 with exceptions below

Planned event through Neighborhood Council

Group size ≥ 7 Individuals

Permit required - Time duration 2 hour restriction

Type P5 - No Amplified Sound

Conservations Lands - no amplification permitted

Neighborhood/Pocket parks with no buffer zones

Any land not listed specifically allowing amplified sound - NO Amplification

Amplification not permitted during school hours if park is adjacent to a school.

Time duration does not exceed 1 hour
