**Summary Description and rationale of project and funding sources:**

Neighborhood requested updates to Bonner park including outdoor fitness equipment, sport court enhancements and additional storage and ada access to the existing bandshell. The current priority for the park is updating the bandshell to provide ADA access, update the electrical system, and repair the failing roof. The bandshell updates were designed in kind by a local architect in 2020. In-kind design service is valued at \$9,000. The ADA access improvements will be funded via private donations and is estimated to cost \$35,000. Roof Replacement and electrical upgrades are needed and are estimated to cost \$105,000.

**History & Current Status: Impact if Cancelled or Delayed**

The bandshell was installed in the 1980's and has received very little updating since. The structure does not meet ADA, and the roof is 50 years old and failing. The electrical system is also in need of updates to bring it up to code. The neighborhood has requested outdoor fitness equipment be added to this park. There are many seniors in the neighborhood that utilize the park for daily exercise and this equipment would be well utilized. The existing tennis court is in need of renovations and the popular sport of pickleball should be added to create a more multi-use court space. The addition of pickleball was requested by the neighborhood. The park improvements are included in FY2025 CIP.
