1) **ADVANCE COURTESY NOTICE★**

Advance Courtesy Notices plus the 48-Hour Notice apply on collector or arterial streets as shown on the city's functional classification map and alleys in commercial areas that are used for regular deliveries, access to parking lots or other commercial uses. These notices shall be in writing to all property owners or tenants and businesses adjacent to the street or alley closure. Notice shall be provided to businesses within the limits of the advanced Detour warning sign locations for the approved traffic control plan, and, in all cases, to businesses within 200 feet of the closure. Advance notice is to be done at least 14 days in advance of the work.

INFORMATION TO BE PROVIDED IN THE NOTICE:

Estimated or approximate date of start of street or alley closure.

Length of time – days to be closed.

Company name and phone number for further information.

Notice will state that a second notice will be given at least 48 hours in advance of closure.

3) RESIDENTIAL STREET OR ALLEY CLOSURE★

48-Hour Notice is required for a residential street or alley closure of more than one day in length. This notice is done at least 48 hours in advance. Notice shall be in writing to all property owners or tenants and businesses adjacent to the street or alley closure Notice shall be provided to businesses within the limits of the advanced Detour warning sign locations for the approved traffic control plan, and, in all cases, to properties within 200 feet of the closure.
