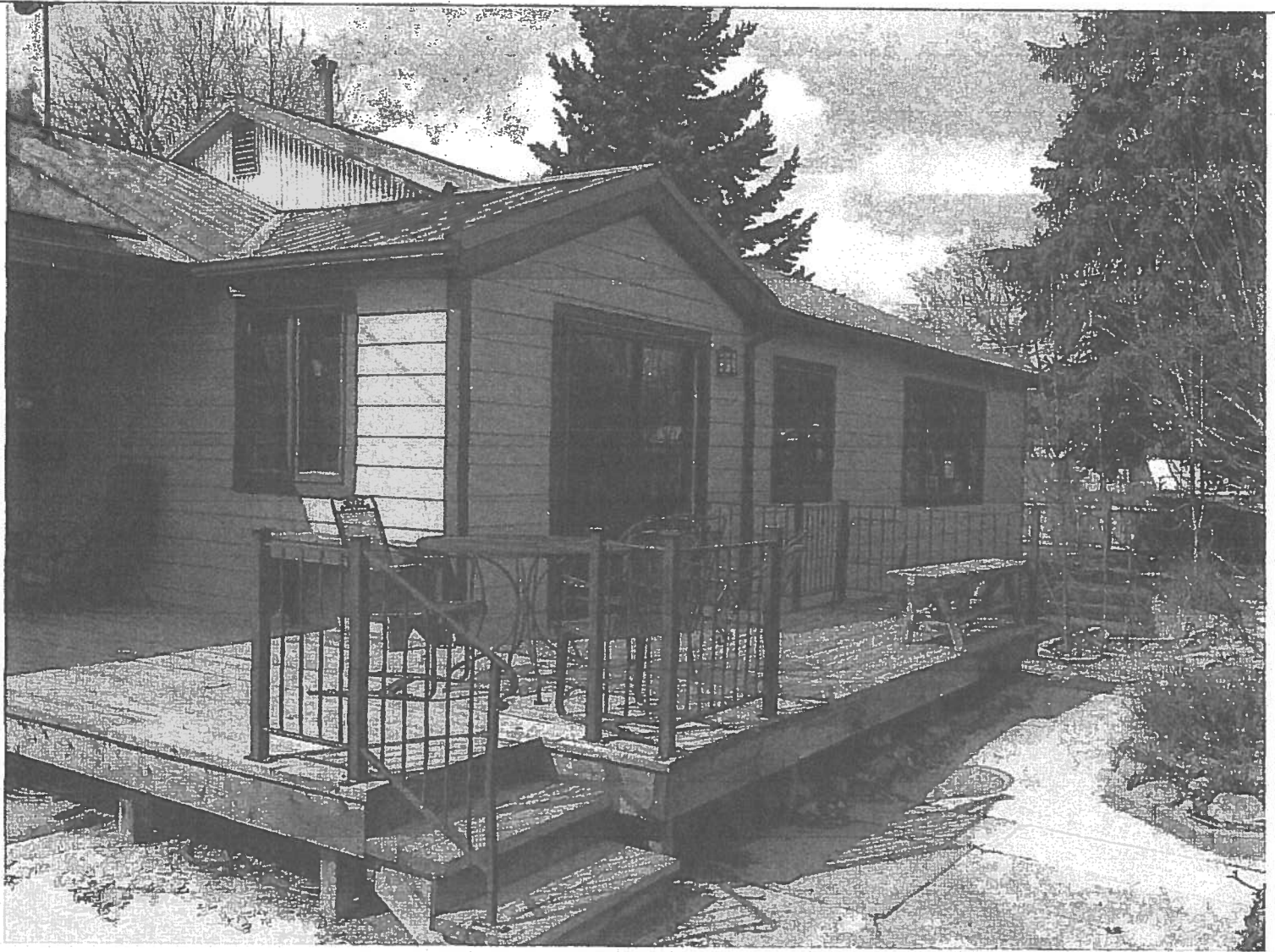

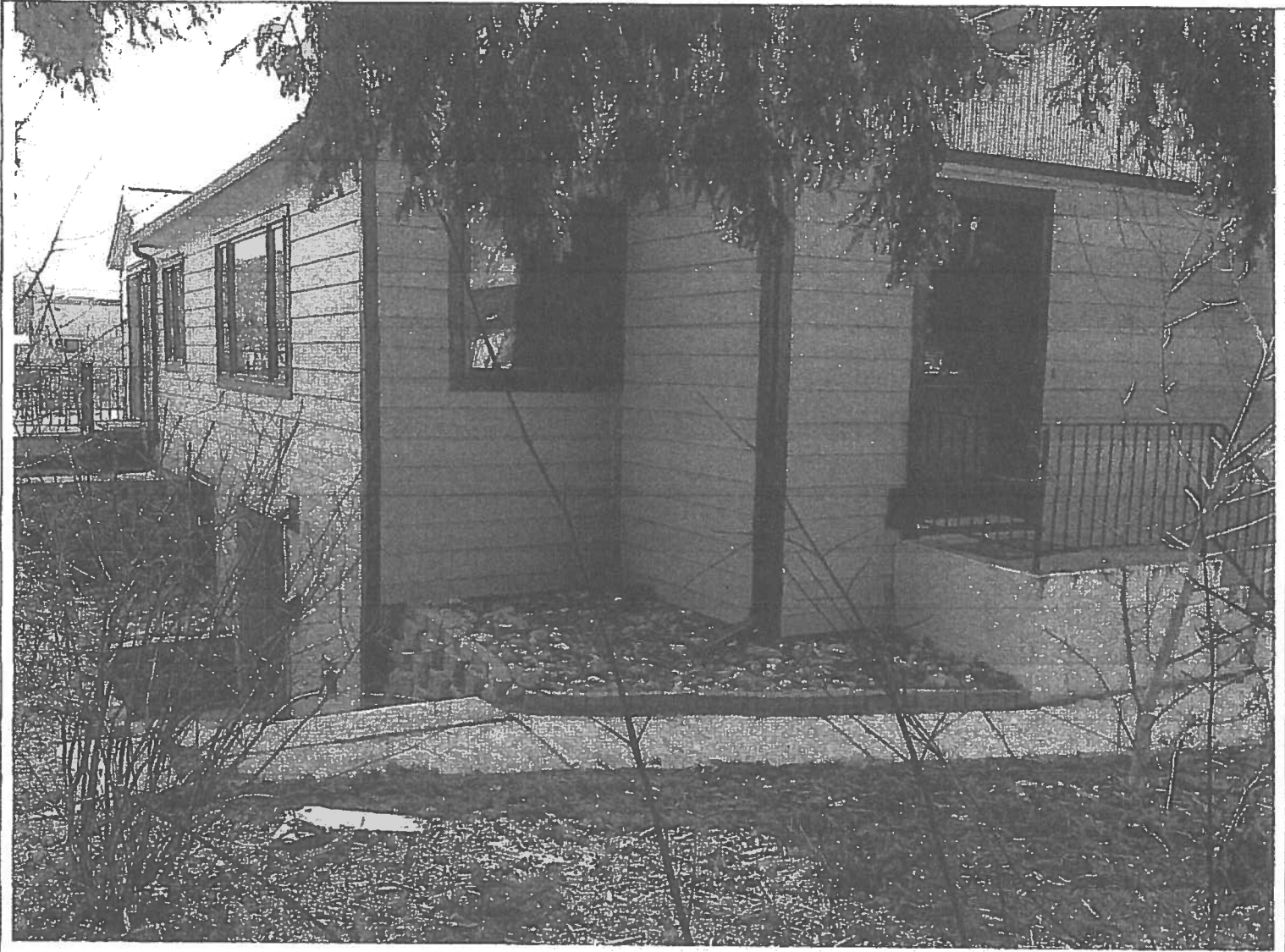
Rear view, looking Northwest (taken March 26, 2014).
