Summary Description and rationale of project and funding sources:

This CIP item is carried-over from the FY23 CIP and is a project to install trail lighting on the Bitterroot Trail from the intersection of the Bitterroot and Milwaukee Trails in URD II to the east side of the S. Reserve Pedestrian Bridge in URD III. The trail segment from S. 3rd St. W. to 14th Street will be part of the project with this infrastructure connection between the URD's benefiting both URD II & URD III by enhancing public safety for all trail users. Upon approval by the MRA Board of Commissioners, the project will be funded with URD II & URD III Tax Increment Funds.

History & Current Status: Impact if Cancelled or Delayed

The lighting of the Bitterroot Trail has long been anticipated. Without the use of TIF from URD II & URD III the trail will not likely be lit in the foreseeable future. Cost estimated are based on of previous lighting cost estimates from other recent trail lighting projects.
