**Summary Description and rationale of project and funding sources:**

Complete curb/gutter/sidewalks, ADA improvements, bike facilities, storm drainage, and street maintenance for improved safety and access for pedestrians, bicyclists, motorists, and transit users. Project will be designed and constructed in conjunction with water main replacements on N 5th and Worden.

Funding sources include property owner assessments, Road District, Transportation Impact Fees, and BaRSAA.

**History & Current Status: Impact if Cancelled or Delayed**

This project addresses poor pavement condition and missing infrastructure on collector streets in the Northside neighborhood experiencing development pressure and heavy truck traffic.

Final design and bidding was completed in FY23, but the project was not awarded due to insufficient funds. The FY24 budget request adds additional funding for construction due to inflation. The project will be rebid in FY24.
