Summary Description and rationale of project and funding sources:
 This project will complete the design and install trail infrastructure improvements on Flynn Lane from Camden to Siren and on Mullan Road from Mary Jane Boulevard to Reserve Street. The Swtpqyen Area Transportation Special Impact Fee has been created to fund this project. In addition, the City & County have recently applied for a Transportation Alternative (TA) Grant to design and construct these trails.

History & Current Status: Impact if Cancelled or Delayed
 The project will complete the work anticipated with the original Mullan BUILD project consisting of a network of collector streets and non-motorized infrastructure. The project will provide for direct transportation facilities and routes to connect people with jobs, health care, schools, and other resources. It will support adjacent land use, provide safe, convenient, and accessible facilities for those living, working, going to school, and recreating in the Mullan Road Area. The City & County committed to completing these trail connections by 2026 as part of the Mullan BUILD grant.

Are there any site requirements/ Potentially Affected Interest (PAI) Coordination:
 Adjacent private property owners will be affected. Private utility lines will be impacted. Coordination, communication, and public engagement will occur to seek input from interested and impacted parties.
