Dear Mr. Throckmorton:

I have conducted a cultural resource file search for the above-cited project located in Section 19, T13N R18W, and Section 24, T13N R19W. According to our records there have been a few previously recorded sites within the designated search locale. In addition to the sites there have been a few previously conducted cultural resource inventories done in the area. I've attached a list of these sites and reports. If you would like any further information regarding these sites or reports, you may contact me at the number listed below.

It is SHPO's position that any structure over fifty years of age is considered historic and is potentially eligible for listing on the National Register of Historic Places. According to the Montana Cadastral there are currently structures over fifty years of age located in Tract 2 COS 6629, and in Parcel A COS 6338. If either of these structures are within the Area of Potential Effect, and are over fifty years old, we would recommend that they be recorded, and a determination of their eligibility be made prior to any disturbance taking place.

Based on the potential of historic structures in the project area and the ground disturbance required by this undertaking we feel that this project has the potential to impact cultural properties. We, therefore, recommend that a cultural resource inventory be conducted in order to determine whether or not sites exist and if they will be impacted.
