

Hello,

I am Dugan Mahoney with Cushing Terrell here in Missoula. We are working on a subdivision in the South Hills area of Missoula, more specifically on the east side of Hillview Way at Hillview Way and Clearview Way intersection (I have provided google earth image for clarity). In Article 3-020.4.G of Missoula City Subdivision Regulations it states "When development is adjacent to or within  $\frac{1}{4}$  mile of an established public transit or school bus route, subdivider may be required by the City Engineer to construct bus stop facilities along with accessible routes, meeting ADA standards, to those facilities. Subdividers should consult with the Missoula Urban Transportation District and Missoula County Public Schools early in the planning and design process." So we are looking to coordinate with Mountain Line and see if a bus stop will be required in our development. Thank you.
