Re: Roseburg Forest Products Co., and Roseburg Resources Co., Annexation Petition

Dear Dave:

On behalf of our clients, Roseburg Forest Products Co., and Roseburg Resources Co., we are requesting annexation into the Missoula city limits and zoning upon annexation for the properties described in the attached annexation petition and overall addressed as 3300 Raser Drive.

The property is currently within the jurisdiction of Missoula County and is zoned Industrial Center Heavy. Upon annexation we would request the property be zoned Limited Industrial (M1-2). According to "Our Missoula Growth Policy 2035", adopted November 23rd, 2015, the desired land use designation for the subject property is Industrial Light and Industrial Heavy. Comparable zoning districts within the Industrial Light designation include M1-2 and comparable zoning districts within the Heavy Industrial designation include M2-4. Our client's primary goal is to annex the property while taking into consideration the surrounding zoning and growth policy designation and acknowledging that the City of Missoula is undergoing a code reform update and associated planning efforts that will likely result in a future change to the requested M1-2 zoning.

The Light Industrial land use description includes "potential uses that do not require an operational permit from the Missoula City-County Health Department (MCCHD) Air Pollution Control Program or a Water Quality District Permit. Uses typically include manufacturing, distribution, research and development, office, technology centers, light assembly, storage, and support services to industry. Encouraging "clean" and "green" industry as new development occurs."

Whereas the Heavy Industrial land use description includes "industries that process large volumes of raw materials into refined products and/or that have significant external impacts. The uses in these areas tend to generate increased truck and rail traffic and should have access to major transportation networks such as highways, railroad, and the airport. Heavy industrial areas include uses that may emit fumes or constant and loud noise; may include businesses that involve hazardous conditions; and may require operation permits from MCCHD."

Given the surrounding zoning, current land uses, and current growth policy designation, the requested M1-2 zoning is most appropriate for the near term. We acknowledge that further City of Missoula planning is forthcoming which may affect change to this zoning designation in the future.

COME NOW the undersigned and respectfully petitions the City Council of the City of Missoula requesting city annexation of the following real property into the City of Missoula.

The petitioner(s) requesting City of Missoula annexation of the property described herein hereby mutually agree with the City of Missoula that immediately upon annexation of the land all City of Missoula municipal services will be provided to the property described herein on substantially the same basis and in the same manner as such services are provided or made available within the rest of the municipality prior to annexation.

Petitioner(s) hereby agrees and submits the real property described herein to municipal taxation and assessments upon annexation, including but not limited to sanitary sewer utility assessments, in the same manner as other private property within the city is taxed and assessed for municipal tax, assessment and utility service purposes.

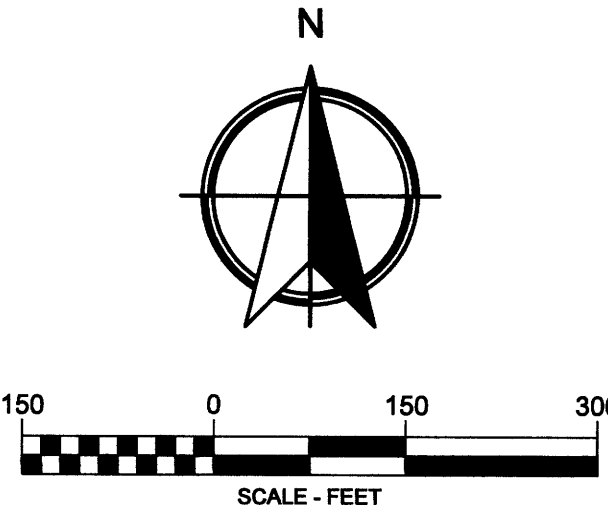

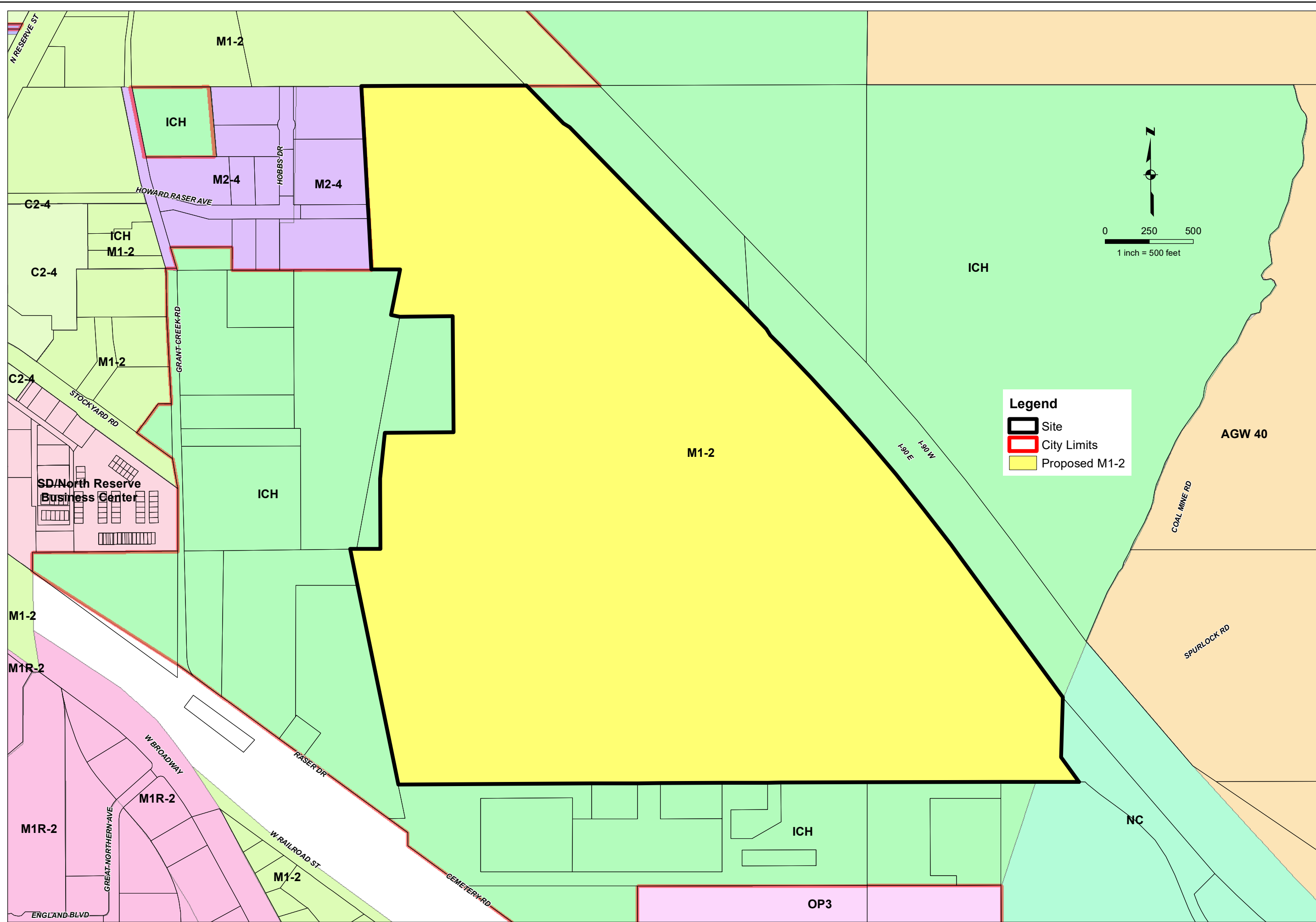


**EXISTING ZONING EXHIBIT

MISSOULA COUNTY, MONTANA**





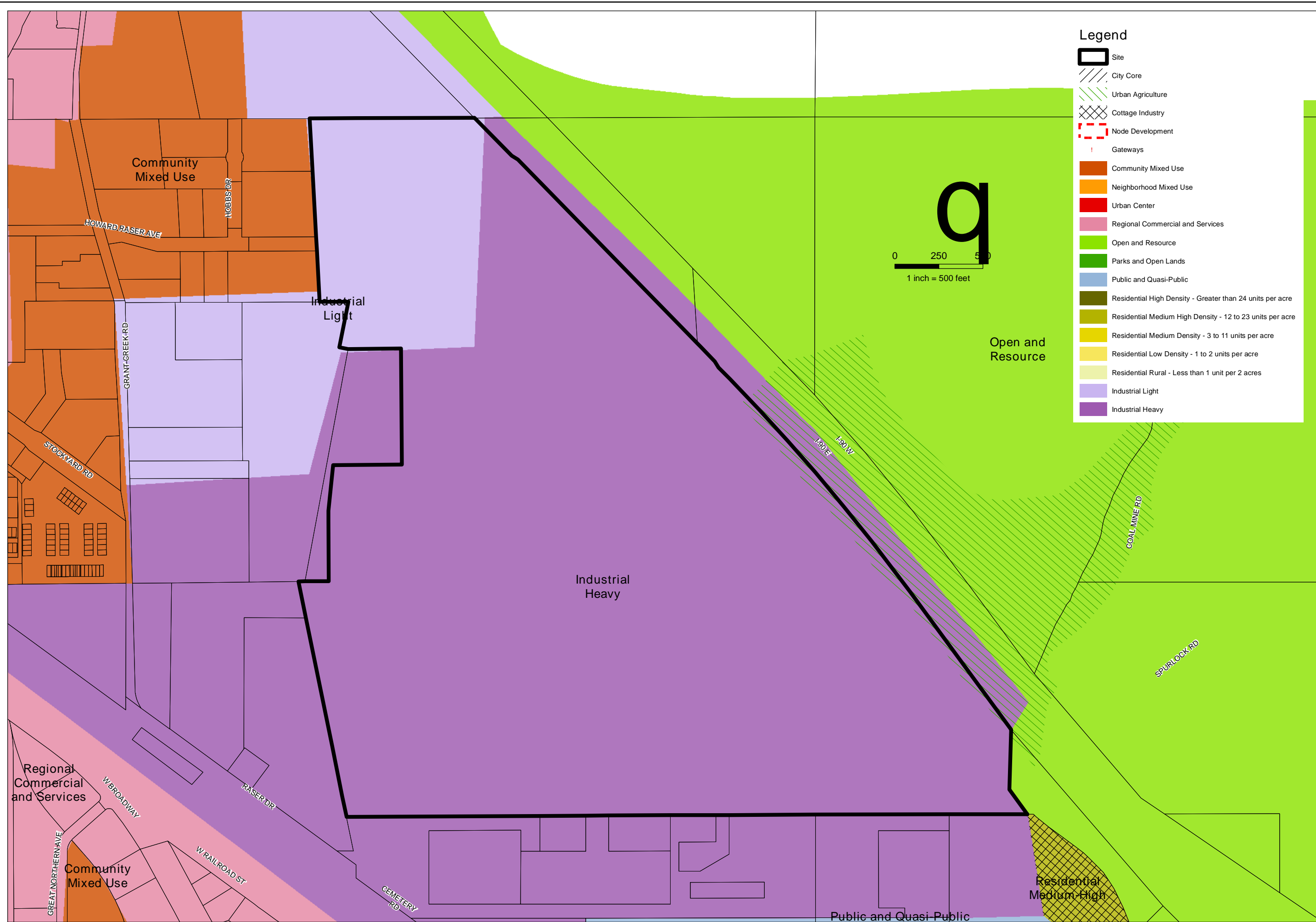
