120% of the Area Median Income

Income verifications are completed by the Human Resource Council for a \$150 fee. If approved, the fee will be included in the principal loan amount. If rejected, the fee will be added to the utility bill.

Applicants must provide the documentation as stated on the back of this form.

A **COMPLETE APPLICATION PACKET** shall include the application and copies of the following documents:

- **Social Security cards** for all household members
- **Income Documentation:**
 - Copy of the last 2 months of pay stubs showing your YTD gross pay;
 - Divorce decree showing monthly child support &/or alimony amount;
 - Statement or letter from Social Security stating monthly benefit amount;
 - Self-employed: 2 years of income tax filings, including Schedule C and Form 8829 "Business Use of Home", and a current spread sheet listing YTD income & expenses, as well as a forecast of the next 12 months.
- **Last 2 months of most recent bank statements**
- Copy of "**Other Assets**" 2 months most recent statement(s) (if applicable – CD's, IRA's, Retirement Plans, Trusts, Stocks, Bonds, Mutual Funds, Life Insurance Policies, etc...)
- **Declaration page of your Homeowners Insurance Policy.**
