

CONVEYANCE OF EASEMENT FOR RIGHT OF WAY

KNOW ALL MEN BY THESE PRESENTS:

That we, KATHLEEN McKINNON, same person as Catherine McKinnon, PATRICIA SINCLAIR, formerly Patricia Flynn, FRANCES McQUADE, ELMER FLYNN and MARY A. FLYNN, his wife, and JOHN FLYNN, a single man, Missoula, Montana, Grantors, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration to us in hand paid by CATHERINE ANDERSON, MARY DAIGLE, HELEN CONNORS and EMMETT FLYNN, Missoula, Montana, Grantees, do hereby grant and convey to the said grantees, their heirs and assigns, the right, privilege and authority to use as a right of way the following described real property located in the County of Missoula, State of Montana, to-wit:

A strip of land in the SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Sec. 12, Twp 13 N., Rge 20 W., M.P.M., particularly described as follows:

Beginning at the Southwest corner of NE $\frac{1}{4}$ SW $\frac{1}{4}$  of said Section 12, thence North along the quarter section line a distance of 1980 feet more or less to the Northwest corner of the S $\frac{1}{4}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$  of said Section 12; thence East along the quarter section line a distance of 28 feet; thence due South a distance of 1980 feet more or less to the quarter section line; thence West along the quarter section line a distance of 28 feet to the point of beginning.

The Grantees may fence said right of way if they so desire.

TO HAVE AND TO HOLD the same unto the said Grantees, their heirs and assigns, forever, as long as said land is used for right of way purposes, and if same is ever abandoned for such purpose, then this Easement shall be null and void and of no further force and effect and title shall revert to the Grantors, their successors or assigns.


