Required repair of replacement of the crumbling Bank Street parking structure. To be covered though a bond with Parking Commission revenues									
History & Current Status: Impact if Cancelled or Delayed									
This program was approved in FY24 for approx \$1.2 million. Some of that was used to fund a conditions assessment which revealed a higher level of repair was required. We are currently in a design process for the repair. The estimated cost of full repairs is \$6,015,000. This less the already approved \$1.3mil leaves needed approval of \$4,731,307. Repair is necessary for safety. Our new contractor estimate for total repair costs is \$4,000,000.00. \$1,320,327.00 carry forward into FY26 from the FY25 CIP.
