How will request assist in achieving Department Goal and benefit the customer</p> <p>The Community Experience and Culture position and its scope of work is in alignment with and a direct application of the City-wide strategic goals to: Continue the City's efforts to ensure that all residents have equitable access to health and wellness; and To increase community engagement and understanding of City services, initiatives and resources. This position increases engagement, inclusion, and awareness through relationship building, which leads to more transparency and builds community trust. The position is an implementation of our mission of "Reflecting the needs and values of our residents, the City of Missoula commits to enhancing opportunity and quality of life through effective delivery of City services." While housed in the Parks and Recreation department, this position can has resulted in improved representation and relationship building in the community for the broader organization. This work leads to a more engaged community where all residents feel welcome to participate in city governance, gain access to city services, and more likely to contribute to neighborhood and community well-being. The Community Experience and Culture position supports the City Council, Mayor, and Board of County Commissioners joint advisory board on access and engagement, the City's internal strategic initiatives teams, advises various city departments and Parks and Recreation collaborations focused on increasing access to programming. This position advises the department employees on tools and strategies for engagement, and messaging to ensure all residents regardless of demographics can find a path to thriving and better understanding how to engage in our community. The position develops relationships and partnerships with residents, non-profits, networks, governments, and businesses to more fully engage and support community well-being and the Parks and Recreation Department and the broader organization. Engagement often occurs in community venues and at community events. Engagement, or more accurately listening, may occur through meetings or other small group or one-on-one settings.</p>
