Summary Description and rationale of project and funding sources:							
Redevelopment of Northside Park Annex (commonly known as Northside ballfield), owned by Resurrection Cemetery Association and operated by Parks under a land use agreement, was envisioned as part of the NS Parks Master Plan process. Planned improvements in Northside Park Annex include upgrades to the irrigation system from the manual system in place currently, expansion of green space to provide a larger multi-use field area, installation of a connector path, and planting shade trees. Park Impact Fees will be used in FY26 and FY27 to fund improvements that increase capacity at the park.							
History & Current Status: Impact if Cancelled or Delayed							
The City has secured long term rights for use of the Northside Annex through an MOA with Resurrection Cemetery Association. The City also received approval to spend \$150,000 in impact fees on improvements that increase capacity. This project may need to be delayed in order to acquire enough funds to carry out the master plan improvements.
