Summary Description and rationale of project and funding sources:							
Downtown Lions Park is part of the adopted North Riverside Parks and Trails Master Plan. The park's location at the intersection of Ron's River Trail and the California Street Pedestrian Bridge and adjacent to a riparian area positions it as an important neighborhood hub. However, the park faces issues of public safety and environmental hazards. Second, a lack of connectivity on Ron's River Trail limits usefulness of the portion of the trail through the park, and makes it important to consider larger connectivity (addressed with the Flynn Lowney/ West Broadway River Corridor Project). Since plan adoption, additional feasibility studies, partnerships, and public input have informed an evolved plan concept. Proposed improvements include a basketball half court, an active play space, a portaport, art, and lighting.							
History & Current Status: Impact if Cancelled or Delayed							
The North Riverside Parks and Trails Master Plan was developed in 2020. In 2021, Native Americans Against Drugs & Alcohol (NAADA) selected the park as a space to improve community health outcomes. NAADA, Parks & Recreation, and the University of Montana applied for a grant for the park that was not funded. Parks & Recreation, NAADA, and All Nations Health Center partnered with Great Western Recreation to receive discounted park amenities. In 2022, Parks and Recreation hosted a series of listening sessions with All Nations Health Center and Youth Homes. The project stalled due to a shortfall in funding, but design development will continue alongside the Flynn Lowney/West Broadway River Corridor Project in FY26.
