<p>Priority Park Asset Management projects to replace aging/degrading/non-compliant infrastructure include replacement of sports field lighting at McCormick Park, additional repair or replacement of aged non ADA compliant sidewalks and concrete across the entire Parks system, trail repair at Mountain View Trail, Lafay connector Trail, and Ron's River Trail Goldsmith section, replacement of aging and non ASTM compliant playgrounds at Playfair Park, Pheasant Run Park, Honeysuckle Park, South Side Lions, Sgt. Gregory and Lester Park, replacement of parking lot at McCormick Park, replacement of irrigation system at Southside Lions Park, replacement of aged well pumps and addition of variable frequency drives, failed playground parts, and repairs of plumbing, irrigation, electrical. Projects will be prioritized based on funding approved.</p>
