Summary Description and rationale of project and funding sources:

Nine (9) sport courts in the park system were identified as needing either significant repair and or replacement. The courts are located at: Marilyn, Skyview, Honeysuckle, Bonner, Wapikiya, Franklin, Northside, McLeod and Whitaker parks. Expansion of five of the nine courts from a single use court to a multi-use sport court would improve recreational options, while also addressing population growth and changing trends for the associated neighborhood and user groups. Improvements include court size, line paint, new multi-use goals, basketball stations, tennis infrastructure, ADA access and site restoration. The project is funded through both Park District and Park Impact Fees. FY24 funding allowed the addition of Skyview sportcourt to be upgraded from a single use court to a multi-use court in FY24. Playfair, Bonner, McLeod and Wapikiya were crack filled and seal coated in FY24. Allocation of remaining funds will be used in FY 26 for tennis court resurfacing at Pineview, St.Gregory and Kiwanis park tennis courts.

History & Current Status: Impact if Cancelled or Delayed

Staff determined that reconstruction of Marilyn, Franklin and Skyview would have the greatest community benefit based on current conditions, level of use and available funding. January 2023, Marilyn, Franklin and Skyview (bid alternate) were released for bid. Reconstruction of Marilyn and Franklin sport courts were awarded March 2023 with substantial completion autumn 2023 leaving site restoration and court striping to be completed in 2024 as weather allows. Skyview court reconstruction was added to the Marilyn and Franklin contract in October 2023 with completion in 2024. Sport court projects to be funded in order of priority as of 5/30/23: Skyview park (complete 2024), Bonner park, McLeod Park, and Wapikiya. In addition, Parks and Recreation funded asphalt preservation with Park District funds at: Honeysuckle, Bonner, Wapikiya, Northside, McLeod, Whitaker and Playfair parks in 2024. Parks and Recreation staff identified Pineview, Gregory and Kiwanis tennis courts as the highest need to resurface to prevent court conditions from deteriorating and impacting the quality of play using remaing funds as a contract value of \$128,000. The work will extend the courts beneficial use. Identified tennis courts were resurfaced in 2009 (Pineview) 2005 (Gregory & Kiwanis).

Are there any site requirements/ Potentially Affected Interest (PAI) Coordination:

Cancellation or delay will not address safety and liability concerns as remaing courts will continue to decline with cracking and raveling (disintegration of the asphalt surface) Project costs will increase over time if not funded.
